- IV. Incorporation - Miss Navajo Nation Council
  - A. Update – incorporation documents were submitted by Karletta Chief to Sacks Tierney. We received a letter from, the AZ Corporation Commission stating that our articles were filed on July 21, 2006. We have 90 days to publish our articles in a newspaper. Articles must be published for 3 consecutive days. We will be publishing in *Record Recorder*. Originally, we wanted to publish in Navajo Times but the cost to print for 3 consecutive days was a total of \$1615.04. We decided to incorporate in Maricopa County because the cost to publish was significantly less. We used Sarah Luther’s sister’s address as our place of business. We will later submit a change of business site to AZ Corporation Commission. This will not be difficult to do. After this is all done, we will release a press statement to the Navajo Times to announce our incorporation.
